Section A: Statement of Purpose

Our Mission is to practice, live and impart the Integral Yoga teachings of Sri Swami Satchidananda to experience supreme peace and joy, and to share that peace and joy with one and all.

Satchidananda Ashram–Yogaville is committed to maintaining a safe, supportive and peaceful environment that fosters spiritual growth for all who work, serve, live, visit or participate in programs, retreats and trainings. Toward that end, we have a Code of Conduct as well as some related documents. Ultimately our aim is to achieve the Goal of Integral Yoga.

Section B: The Goal of Integral Yoga

The goal of Integral Yoga, and the birthright of every individual, is to realize the spiritual unity behind all the diversities in the entire creation and to live harmoniously as members of one universal family. This goal is achieved by maintaining our natural condition of: a body of optimum health and strength, senses under total control, a mind well-disciplined, clear and calm, an intellect as sharp as a razor, a will as strong and pliable as steel, a heart full of unconditional love and compassion, an ego as pure as crystal, and a life filled with Supreme Peace and Joy.

Section C: Ensuring Non-Discrimination and Non-Harassment at the Ashram

Ashram leadership does it's best to ensure that all those visiting, serving or living at the Ashram are able to enjoy an atmosphere free from sexual or other inappropriate conduct, harassment and retaliation. A safe, supportive environment is further ensured by all striving to follow the expected conduct, as outlined in the Ashram Lifestyle Principles. Failure to abide by the expected conduct includes unwanted or inappropriate physical contact, sexual advances and other inappropriate behavior or harassment of a sexual or aggressive nature.

The Ashram is committed to maintaining a space that honors diversity and equity. We prohibit discrimination and harassment based on race, color, faith, sex, gender identity, national origin, disability, age, sexual orientation, or status in any group protected by law, in compliance with federal, state and local regulations.

Section D: Reporting and Resolution Process at the Ashram

If you believe you have witnessed or been subjected to inappropriate or unwanted behavior, sexual or other harassment, or discrimination, that has not been adequately resolved, please notify the Ashram's Human Resources Department at <u>humanresources@yogaville.org</u>.

Our complaint and grievance process provides that complaints be promptly and impartially investigated in a compassionate and professional way. If the unwanted behavior is confirmed in the investigation, prompt and effective action will be taken to remedy the situation. The complainant will be assured that an environment free from harassment has been restored and that there will be no retaliation of any kind toward anyone who has participated in the investigation.
